Grantees are selected on an objective and nondiscriminatory basis in close consultation with the diocesan bishops of the Church who have authority over them, and who assist in verifying the extent of need of each grantee and the degree to which such need exceeds the amount of financial assistance which the diocese is able to provide. The diocesan bishops of the Church have a significant voice in the timing of grant payments, the manner of making them, and the selection of recipients. This activity directly furthers the exempt purpose of the Church by performing a function of the dioceses of the Church, namely supporting its clergy in their capacity as ministers of the Church.
